MATERIALS ACCEPTED AT THE CENTER

BULKY HOUSEHOLD ITEMS INCLUDE (FEE REQUIRED)

Household Garbage, Televisions, Upholstered Furniture, Wood Furniture, Fiberglass Tubs/showers, Plastic Pools, Mattresses, Non-recyclable White Goods and Microwave Ovens (low metal content)etc.

WHITE GOODS AND METAL THAT CAN BE RECYCLED (FEE REQUIRED)

Ferrous and Non-ferrous Scrap Metal, Metal Household Appliances, Water heaters, Outdoor Grills, Air Conditioners, Burn Barrels(barrels must be empty), etc.

NOTE*** To be accepted, metal items must be free of major - wood, fiberglass, plastic or other non-metal or organic attachments. **Microwave Ovens** and similar appliances that are mostly made of plastics are not recyclable as scrap metal. No tires will be allowed in metal pile.

CONSTRUCTION AND DEMOLITION DEBRIS (FEE REQUIRED)

Scrap lumber, plywood and wood products, sheet rock, gypsum board, shingles, floor covering (vinyl, composition tile, carpet) vinyl siding, doors and windows, etc.

TIRES (FEE REQUIRED)

Mounted or un-mounted automobile and truck tires are accepted. **Tractor, Skidder and Skid Steer and industrial tires are not accepted due to handling difficulties and high disposal cost.**
