

**Proposed Solid Waste Regulatory Policy
Pursuant to Lincoln County Code, Section 58-173. Terms and conditions for
release of the solid waste management fee for solid waste management services:
Limited or Fixed Income.**

This policy creates a procedure whereby the owners of real property may request release of the *Solid Waste Management Fee*, hereinafter referred to as *fee*, imposed for solid waste management services.

The Board of Commissioners establishes a Solid Waste Management Fee, to fund solid waste management efforts within the unincorporated areas of Lincoln County for the collection of Solid waste. In addition to these primary functions, solid waste management includes roadside litter abatement, special waste management and disposal, recycling, and state mandated public education programs concerning waste reduction and recycling.

The Board recognizes that some elderly real property owners may be financially disadvantaged by limited or fixed incomes and furthermore that the imposition of the solid waste management fee may present an undue financial hardship on such individuals. With the approval of the Lincoln County Department of Planning & Zoning, Office of Solid Waste, these individuals may be eligible for the release or reduction of this fee. The criteria for consideration of release or reduction for this *fee* imposed for solid waste management is as follows:

- The individual must demonstrate that the Gross Annual Household Income is \$10,000 or less.
- The individual must qualify as "Head of Household" under IRS rule.

Owners seeking release of the fee must complete the appropriate form and return it to the Lincoln County Department of Planning & Zoning, Office of Solid Waste no later than the due date of the tax year in which the release is requested. Releases cannot be made if the form is filed after the tax due date. A copy of the form is attached to this policy (Form: SW5-3). The Lincoln County Department of Planning & Zoning, Office of Code Enforcement shall make the investigation and determination as to the validity of the application.
